STUDENT's Roadmap for College Application Success

SAT

Preparing for college starts early! The steps you take now can make a big difference later. Use the roadmap below to stay on track and rely on your Counselor or College & Career Coordinator and your family for support through the process.

Experiences Outside of the Classroom

Extracurricular activities are important because they allow you to contribute to your community and discover interests outside of academics. How you spend your free time is just as important to colleges as your grades and test scores. Actively participating in a couple of activities that you enjoy is more important than being involved in many groups!

- ☐ Get involved in extracurricular activities, internships, jobs, and family responsibilities.
- Take on leadership roles in clubs, sports, or community organizations.
- Apply for summer enrichment programs.
- □ Keep track of your involvement by creating a resume. This will help you remember all of your accomplishments and will be useful when you apply to jobs and colleges.



Test scores from the SAT or ACT are used by some colleges to assess your academic preparedness for college. Even at test-optional colleges, scores may be used for scholarship and merit aid consideration. Do your research! Some colleges will accept your super score, the combination of your highest scores from each test section. Testing multiple times allows you to achieve a higher super score.

- Prepare for the PSAT/SAT by using Khan Academy, taking practice tests, and participating in SAT test preparation at your school.
- Take the PSAT in the Fall of 9-11th grade to build testing skills and qualify for scholarships.
- Participate in the free DCPS SAT School Day during the Spring of 11th grade and Fall of 12th grade.
- If you choose, take an SAT or ACT weekend exam. Ask your counselor about an SAT weekend fee waiver.

Applying Successfully

Colleges have early application deadlines in the fall of your 12th grade year, and meeting these deadlines can boost your chances of admission and securing scholarships.

- Apply to at least 2 Smart Colleges.
- Complete application via the Common App, Common Black Application, Coalition for College, or direct to the college.
- Request transcripts and recommendation letters through Naviance.
- □ Finalize college essay by having it edited by a trusted adult.
- Check email often for missing application materials.
- □ Write an activities list that showcases your accomplishments and leadership.

The most important admissions factor colleges consider is your academic profile, which includes your GPA and the challenging courses you are taking throughout high school.

- GPA stands for Grade Point Average and is a numerical
 - representation of a student's average performance across all their courses. At DCPS, your unweighted GPA may be 0-4.0; a weighted GPA includes more credit for advanced classes.
- □ Check your GPA on your transcript or calculate it <u>here</u>. Strive for strong grades in all your classes.
- Challenge yourself by taking AP, IB, Dual Enrollment, or Career. Academy classes. These classes demonstrate your academic drive and interests to colleges.
- Seek support from your teachers or counselors if you are struggling in a class.

Exploring Colleges

Smart Colleges are institutions from which you have a higher likelihood of graduating based on your academic profile. You will be recommended to consider certain colleges based on your GPA and test scores.

The stronger your GPA and test score, the more selective universities you should be applying to.

- Meet with your counselor and/or college and career coordinator to identify your Smart College target.
- Use Naviance and BigFuture to research colleges.
- □ Visit colleges by going to campus tours, fly-ins, and open houses.
- Attend college events offered by DCPS, such as college & career fairs at your school and DCPS Goes to College Month in May.
- By early 12th grade, finalize your college list. It should include a mix of likely, match, and reach colleges & universities.

Paying for College

Each student's cost of attendance will differ; you will not know your cost of attendance until you submit your financial aid applications. As a family, discuss whether and how much your family can contribute toward the cost of college.

Complete financial aid applications early senior year to maximize your financial aid for college.

- Explore <u>colleges that meet 100% financial need</u>.
- Use <u>Net Price Calculators</u> to estimate what your family may be expected to pay toward tuition.
- Apply for scholarships as early as 9th grade! Sign up for the DCPS
- Prepare to submit the <u>FAFSA</u> and the <u>CSS Profile</u>. Families
- planning to complete the FAFSA should file taxes if eligible.
- Check your eligibility for DC grants and scholarships like <u>DCTAG</u> and <u>Mayor's Scholars</u>.




